

# **MARILLA SNO-MOB SNOWMOBILE CLUB**

## *CONSTITUTION*

### **ARTICLE I NAME**

THE NAME OF THIS ORGANIZATION SHALL BE 'MARILLA SNO-MOB SNOWMOBILE CLUB INC'. ITS MOTTO SHALL BE 'EVERYTHING IS BEAUTIFUL'.

### **ARTICLE II OBJECTS**

- A. TO ENJOY THE SPORT OF SNOWMOBILING IN SUCH A MANNER SO AS NOT TO INFRINGE UPON THE RIGHTS, PRIVACY OR SAFETY OF OTHERS.
- B. TO MAINTAIN A LINE OF COMMUNICATION WITH LOCAL GOVERNMENT AND LAW ENFORCEMENT AGENCIES RELATIVE TO THE SAFE AND LEGAL OPERATION OF SNOWMOBILES.
- C. TO DEVELOP A SEARCH AND RESCUE PATROL AVAILABLE FOR AID AND SERVICE DURING "SNOW EMERGENCIES" OR WHEN OTHERWISE NEEDED.

### **ARTICLE III MEMBERSHIP**

MEMBERS WILL BE AT LEAST EIGHTEEN (18) YEARS OF AGE (CHILDREN UNDER 18 YEARS OF AGE ARE INCLUDED IN THE FAMILY MEMBERSHIP).

### **ARTICLE IV OFFICERS**

THE OFFICERS OF THIS CLUB SHALL BE A PRESIDENT, VICE PRESIDENT, SECRETARY, AND TREASURER, WHO SHALL SERVE FOR ONE (1) YEAR. OFFICERS SHALL BE ALLOWED TO SUCCEED THEMSELVES FOR 2 ADDITIONAL ONE-YEAR TERMS. THEY MAY CONTINUE IN THE OFFICE FOR ADDITIONAL TERMS IF THEY ARE UNOPPOSED.

### **ARTICLE V MANAGEMENT**

THE BUSINESS AFFAIRS OF THE CLUB SHALL BE TRANSACTED BY A BOARD OF DIRECTORS WHICH SHALL CONSIST OF THE OFFICERS, WHO SHALL SERVE FOR ONE YEAR AND EIGHT DIRECTORS, FOUR OF WHOM SHALL BE ELECTED EACH YEAR FOR TERMS OF TWO YEARS, PROVIDING THAT ALL MATTERS INVOLVING THE FINANCIAL ASSESSMENT OF MEMBERS, AND OTHER MATTERS OF PARTICULAR INDIVIDUAL INTEREST, IN THE DISCRETION OF THE BOARD OF DIRECTORS, SHALL BE SUBMITTED TO THE GENERAL MEMBERSHIP OF THE CLUB FOR ACTION.

### **ARTICLE VI AMENDMENTS**

THE CONSTITUTION MAY BE AMENDED BY A TWO-THIRDS (2/3) VOTE OF THE MEMBERS PRESENT AT A REGULAR MEETING, PROVIDED NOTICE OF THE PROPOSED AMENDMENT SHALL HAVE BEEN SUBMITTED, IN WRITING, TO THE MEMBERS AT LEAST THREE (3) WEEKS PRIOR THERETO.
